04. That the school shall comply with the provisions of Section 10(1) read with Rule 125 of DSEAR, 1973.
05. That the school shall comply with clause 14 of order No. F. DE/15(56)/ACT/2009778 dated 11.02.2009 in r/o maintenace of DRF. School also ensure to follow FN-21 Accounting by School" as issued by the Institute of Chartered Accountants of India (ICAI) for proper accounting treatment.
06. That the school shall make payment of salary and other admissible allowances to its teaching/non-teaching staff as per ongoing CPC through Bank/RTGS.
07. That the school shall provide the PF facility within 02 months and submit the requisite documents to the district authority.
